#### 7. <u>Reports if any from County Cllr and or Borough Cllr</u>

Borough Councillor's Robin Betts & Martin Coffin – Written Report

#### Borough Councillor Report

1. MOTO

Martin and I attended Area 2 last week, as we are friends of the landowner we had to declare an OSI (Other Significant Interest) which had the consequence that we are unable to participate in the debate and unable to vote, but we were given the opportunity to speak on the application for 3 minutes.

I raised concerns over inappropriate development within MGB and that the very special circumstances given "exceptional need of lorry parking" were in my opinion insufficient. The analogy I cited was the "exceptional housing need in TMBC" in my opinion this could not be used as a blanket VPC to overcome inappropriate development in MGB.

I commented on the negative impact on ANOB or as now classified Kent Downs National Landscape.

I then just had time to mention light pollution.

Martin concentrated on the Traffic assessment and the critical error of carrying out traffic modelling based on data taken during COVID lockdown period and that this could therefore not be relied upon. Also highlighted a number of areas that were not assessed along the A20 including the numerous roundabouts.

After long debate the application was refused as per the Officer's recommendations.

- 2. Full council last week agreed a 3% rise in council tax.
- 3. Critical funding gap continues and stands at  $\pm 1.7$ m over the MTFS.
- 4. Tonbridge Town Centre development papers released yesterday, exciting plans to be decided by members and a site to be identified for a new state of the art, carbon neutral leisure centre.
- 5. 180 PV panels starting to be installed at Tonbridge swimming pool. This all helps to secure the future of our leisure services for our residents.
- 6. More rounds of Green business grants (£40K of grants) and West Kent Rural grants (£125k of grants)
- 7. Phase 2 of EV chargers starts, with 60+ chargers in and around TMBC.

KCC has agreed the 2024-25 budget setting a council tax increase of the maximum allowed of  $\pounds 5\%$ .

Significant savings will be required to fill the 84.4m budget gap. Peter Oakfield has described this as the 'toughest year we have ever faced'

Cuts will be made to areas including arts funding, adult and youth services and other nonstatutory expenditure.

Water is again running of the Spring Tavern site onto the A20 causing a significant risk to motorists. The situation has been reported to KCC officers along with details of the site owners.

KCC Planning Officers declined to respond to the MOTO application after accepting the applicant's traffic impact analysis without any independent verification. The transport assessment commissioned by local parishes indicates the application will have a significant impact on the local road network. KCC could find themselves being held to account on this decision if MOTO appeal the decision by T&MBC to refuse the application. Kent Downs AONB submitted a robust objection to the proposal. As both the KCC & KALC delegate for Kent Downs AONB, Harry has 2 votes within the organisation.

#### 8. <u>Reports from various Committees</u>

#### <u>Grounds</u>

A new storage bin and work bench have been built in the new depot, attached report refers.

### <u>Buildings</u>

St George's Hall gutter downpipe has been cleared and main guttering recited, attached report refers.

#### <u>Highways</u>

No works have been undertaken in the last month by UK Power Networks, we therefore still have 10 outstanding dangerous connections to be completed and the 2 paid for connection to lights in Bull Lane and at the Lychgate. The attendance of the crew on the 27<sup>th</sup> February to connect the light in Bull Lane was cancelled by UK Power Networks however the traffic management team and digger driver attended, consequently the newly dug hole had to backfilled immediately and the traffic management measures removed. Following this incident Matt Larney of UK Power Networks has been assigned to our project and after a walk around Wrotham with our consultant Mike Mills has promised to have all works completed by the end of March 2024.

#### Crime & Disorder

The Crime Diary has resulted in a proactive positive response from the Community Safety Unit. WPC has been notified that 2 Community Protection Warnings have already been issued. Failure to comply with the warning will result in the issuing of a Community Protection Notice

to stop doing specified things and/or to do specified things and/or to take reasonable steps to achieve a specified result

Continuing activities following the receipt of a Community Protection Notice can result in a fine or the confiscation of goods.

# <u>Planning</u>

The Moto application was refused by T&MBC Area 2 Planning Committee in line with officer's recommendation on the following grounds.

Impact on National Landscape Area No Special Circumstances in overcome harm to the above Insufficient analysis of Alternative Sites.

As friends of the land owner, Martin Coffin & Robin Betts were not permitted the right to participate in the debate or vote on the proposal. They were permitted the same rights as any member of the public to speak to the application for 3 minutes. Mike Taylor and Wendy Palmer as both their parishes are members of the Parish Alliance were also excluding from voting.

Although the officer didn't cite traffic implications as a reason for refusal our barrister Ashley Bowes has confirmed that we can produce and bring forward our analysis of the traffic implications as a Rule 6 Party should the application go to an Inquiry.

# WPC Grounds and Buildings Report February 2024

# **New Depot Preparation Works**

The new depot is an ex-apple store with metal lined walls that can't be drilled. Therefore, all installations must be free standing.



Pete constructed this workbench and shelf to provide a work surface with a metal vice. (Not yet purchased)

It was made largely out of 2x4 and ply salvaged from next doors skip (with permission).

Four pallets have been joined with salvaged 4x4 to create free standing storage. The centre compartments will be used to vertically store our numerous chestnut pale stakes, stock timber carcassing and green oak posts.

The on-edge pallets make useful storage for rakes, spades, forks, and brooms etc.



Some heavy-duty garage type shelving will be ordered and installed soon.

Following some complaints that youths were using the Churchyard to access the exbowls club building, we have installed some 1.1m, 3 wire chestnut pale fencing across the gap.



The stone wall is listed so the fencing has been installed behind the wall between two trees, but using chestnut stakes driven into the ground. We did not want to screw into the ancient yew tree.

The guttering above St George's Hall emergency exit was leaking and the down pipe was blocked.



Pete stripped down guttering and down pipe and cleared all detritus accumulation in the ground socket.

It was reassembled using guttering mastic on all joints.

A leaf guard has been screwed into place at the top of the downpipe.

The wall climbing deterrent agreed at the last meeting is on order.

# **Comments:**

This is the 10<sup>th</sup> planning application on this site and the proposal has steadily expanded in height, width and overall scale such that, if consented, it would appear to be of similar massing to the line of 3 three adjacent dwellings. This is harmful to the character of the rural locality which is contrary to Policy CP24 of the 2007 Local Plan. The proposed expansion of built development south erodes the gap between the line of residential development and the industrial site adjacent, such that it would appear from the street view to merge into a single line of mixed development.





The proposed building, by virtue of its size, location. orientation, form and massing would fail to respect the site and its surroundings and would not conserve or enhance the natural beauty of the National Landscape in which it would be located.

Areas of Outstanding Natural Beauty have been renamed "National Landscapes", and from the 26th of December 2023, a new statutory duty has come into force. This duty says that all "relevant authorities" (including local planning authorities), "must seek to further the purposes" of the designated landscape; for National Landscapes, this purpose is conserving and enhancing natural beauty.

WPC still considers that the proposal is disproportionate to the original building and that this recent case law is relevant to this determination. *Guildford Borough Council v Secretary of State for Levelling Up, Housing and Communities & Anr. Case Number: CO/2321/2022* 

Judge Milwyn Jarman KC ruled that the base line for determining whether a volumetric increase in development was proportionate is to consider the size of the building when the 1947 Planning Act passed into law, or the first building as originally consented after that date. In this case the first consented building resulted from application 21/03372.

# APPLICATION: TM/21/03372/FL VALIDATED: 29 December 2021

The applicant suggests that this new proposal is mere infill. However, if you apply the caselaw criteria then clearly there has been a steady increase in size over the previous 10 applications such that the size of this latest proposal is a volumetric increase of a completely disproportionate amount. The application is therefore harmful to the openness of the Greenbelt and inappropriate development and no very special circumstances have been advanced to overcome the harm.

# Conclusions

WPC objects to this proposal for the following reasons.

- 1. It is harmful to the character of the rural locality which is contrary to Policy CP24.
- 2. By virtue of its size, location. orientation, form and massing it would fail to respect the site and its surroundings and would not conserve or enhance the natural beauty of the National Landscape in which it would be located.
- 3. Due to the amount of volumetric increase from the original consent, it is inappropriate development that is harmful to the openness of the Greenbelt.

In the event that the LPA is minded to consent this proposal then an Article 4 Direction should be used to remove all permitted development rights.
