The minutes of the meeting held on 03rd May 17, were proposed by Cllr Rayner, seconded by Cllr Beach and agreed and signed as a correct record by the Chairman.

5. Public Question Time

Mrs Stratten a resident of the newly built development at Yaldham Manor requested the assistance of WPC in her endeavours to reduce the speed limit on the Kemsing Road. Following the re-development of Yaldham Manor and on completion of the adjacent development at West Yaldham Farm, there will eventually be in excess of 20 residential properties in the vicinity.

Cllr Rayner informed Mrs Stratten that the process involved in obtaining a change in speed limits would be lengthy and obtaining factual data would be necessary.

It was agreed by the council to seek advice from Les Henry Associates on the speed limit criteria in respect of residential property numbers within a given area. The Speedwatch initiative was raised as a possible means of speed monitoring, although the Clerk was of the opinion that the road with its current speed limit would not meet the safety requirement to be eligible for the scheme.

6. Casual Vacancy for Wrotham Parish Council - Co-option Candidate

Mrs Philippa Parker was proposed by Cllr Rayner, seconded by Cllr Gillin and elected with the full support of all members to Wrotham Parish Council. Cllr Mrs Parker duly signed the declaration of acceptance of office. Cllr Parker had received by email the Code of Conduct and all other documents relevant to the governance of WPC prior to the meeting.

7. WPC Website

The Clerk asked members to consider out-sourcing the Parish website as the current software provided by KCC and recently change for the 3rd time was proving difficult to navigate and as a result WPC's website was looking unprofessional. The decision to research alternatives was agreed unanimously by the Council. Cllr Parker agreed to carry out the exercise.

8. Reports if any from County Cllr and or Borough Cllr

County Councillor Rayner gave the following report:

Having been duly elected on the 4th May 17, I have requested to join and have been appointed to the following two committees, Planning & Business Development which is responsible for Land & Property. Since the election, which resulted in the highest number of new Councillors for decades no committees have held meetings. Extensive training sessions are being held for the large percentage of the new Councillors who have no previous experience of government office.

9. Reports from various Committees

Grounds

After the recent heavy downpours of rain following an extensive period of dry weather, a section of the ragstone wall to the Recreation Ground collapsed. Repairs were undertaken the following day, but more work is required to the shore up the aging mortar. LED night vision floodlighting has been purchased for the CPA.

Buildings

The hall is again suffering from water ingress from the flat roof. Repair work has been undertaken today. The area of ceiling affected will be monitored.

<u>Highways</u>

The pedestrian areas of the high street have been surveyed to establish the overall area requiring repaving. Cllr Beach will use this information to discuss this proposal with Kent Highways & Transportation, quotes will also be obtained from other contractors. There has been no further progress with the acquisition of the Nepicar Layby.
